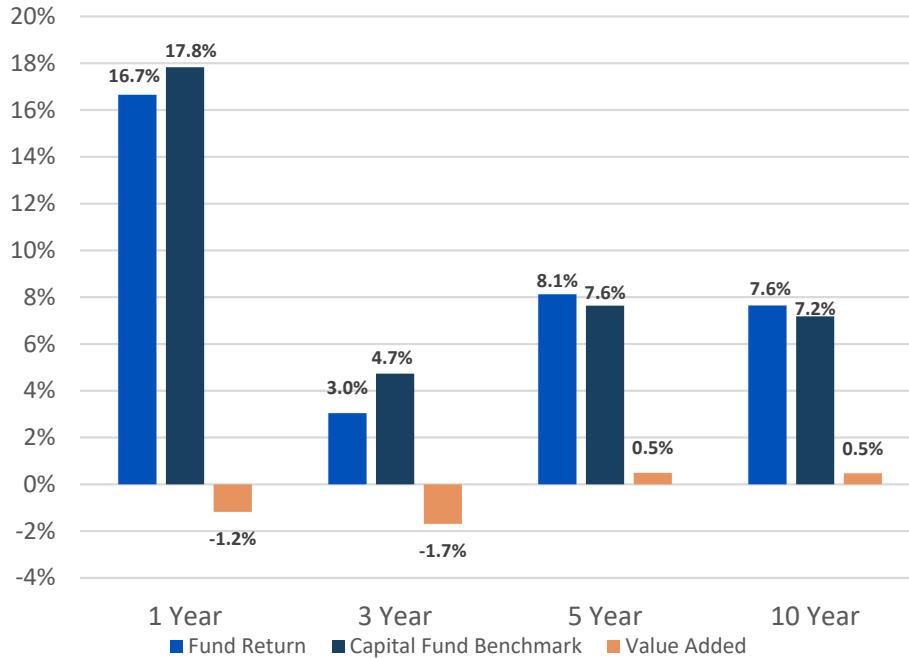
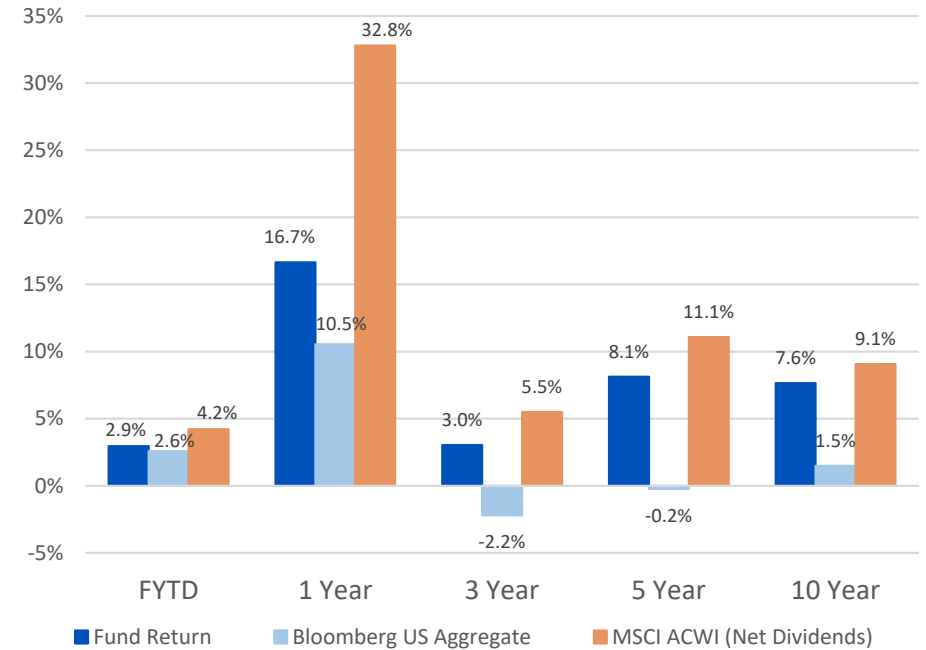


### PRIT Fund Total Returns (Annualized, Net of Fees)

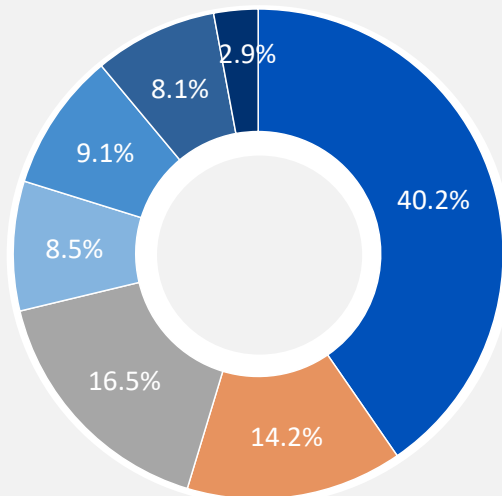


### PRIT Fund Vs Stocks and Bonds (Net of Fees)
